Footnotes

LISTON unhurried early, angled out in the stretch and rallied to be just up at the wire. DREAMING OF LES rated off the pace, rallied to take over inside the eighth pole, then just failed to last. MINISTER COLIN allowed to settle, swung out for the stretch run and closed well to just miss catching the top ones. DEVON ROCK reserved off the pace, rallied four wide around the far turn to gain a slim lead in the stretch, then lugged in through the final eighth while weakening. CARLY'S REAL DEAL taken in hand early, advanced to loom a threat in the stretch but couldn't gain late. VALTER chased the pace along the inside, made a run to reach even terms for command racing into the stretch, then was steadied inside the eighth pole and failed to recover. OH SO DEBONAIRE failed to menace after being outrun early. RATTLESNAKE RED tired from good position. I CAN AND I WILL vied for the lead along the inside to midway of the far turn, then was faltering when steadied in the stretch. ABSOLUTE POWER stalked the pace three wide, then was checked from between rivals leaving the far turn and dropped back. FAST TIME vied for the lead outside I CAN AND I WILL, responded when challenged by VALTER on

the far turn, then faded in the drive. TROPICAL DEPUTY was done early. THERE WAS A STEWARDS INQUIRY INTO THE STRETCH RUN. NO ACTION WAS TAKEN.
