HANDSOME JACK was allowed to settle early, moved up four wide at the quarter pole and finished gamely to be clear under strong encouragement. BEACH MASTER set all the pace along the inside and finished second best. PRIMA ZIP stalked the pace, took up at the eighth pole while racing between horses and had no final winning bid. The jockey of Prima Zip claimed a foul against Handsome Jack and Beach Master for interference in the stretch. The stewards found insufficient evidence and no action was taken. OVER AND BACK was allowed to settle early, moved up three wide and made a mild late gain. PIANO MAN TED stalked the pace, saved ground and had no response. RICO SUAVE failed to respond. SONG FOREVER pressed the pace from the inside and tired. FULL MOON'S BACK was bumped at the start and never was a factor. HUMOR ME DOC was bumped at the start and never menaced.
