BIG BLUE KITTEN stalked the pace, moved up three wide in the stretch to take command and just lasted under all out pressure. ZA APPROVAL stalked the pace, raced four deep in the stretch, slowly closed in on the latter stages to just miss in a game effort. BAD DEBT stalked the pace, saved ground and finished willingly to the wire. JOES BLAZING AARON was quick to begin from the outside and weakened a bit in the drive. ADMIRAL PERRY was allowed to settle early, moved up three wide in the lane and had no excuse. LIL BIT O'FUN was slow early, raced four wide into the upper stretch and never was a real threat. MANCHURIAN HIGH was allowed to settle early, moved up five wide into the stretch and never threatened. EL ROMANO failed to menace.
