HONEY CHILE vied for the lead along the inside, edged away on the turn, opened a clear lead in midstretch, then was ridden out to remain clear to the wire. FLYING TRIP reserved early, swung wide for the stretch run and rallied to prove second best. SOOKIE STACKHOUSE broke a step slowly, tracked the leaders around the turn, then couldn't keep pace with the top ones in the drive. SNOW TRIAL off a step slowly, was not a factor. SKY GLOW rated in striking position off the pace, tired in the drive. TRULY CLASSY vied for the early lead three wide, chased the winner around the turn, then faltered. SIMPLE WORDS showed brief speed between horses, then couldn't stay with the leaders on the turn and faded.
