BRINK OF WAR tracked the early leader racing along the inside, continued a steady bid heading into the turn, edged by leader in upper stretch and held off BRAZILIAN COURT in final strides. BRAZILIAN COURT tracked the early front runners racing along the inside, made a bid in the upper stretch and continued to gain ground to the wire. GUTS TO GLORY stalked the early front runners, raced three wide in the turn and made a mild gain in the stretch. DON OF DONS showed quick early speed, continued to lead by a wide margin and began to falter in the upper stretch. LIVINGSTON SWAGGER settled in behind the early speed runners, made a bid in the upper stretch but had no final kick in late drive. MR LASER raced evenly and failed to rally. KEYNER VELOZ showed little throughout.
