BROADWAY'S ALIBI moved up quickly to show speed along the inside, took over soon after going a quarter mile, then drifted out leaving the turn and through the stretch while drawing off. THE CAT'S ALL THAT chased the pace three wide around the turn and gained the place while no match for the winner. MISS QUISQUEYA tracked the leaders along the inside, then couldn't keep pace with the top one in the drive while being outfinished for the place. ULLAPOOL showed speed off the rail, then couldn't stay with the winner around the turn and tired in the final eighth. PERSONALLY YOURS chased the pace around the turn, then steadied briefly in behind MISS QUISQUEYA in the stretch and faltered. REPOSSEE was through after a half mile. CIGUARAYA showed early foot and faded. ARABELLA'S TUNE was outrun. THE RIDER OF PERSONALLY YOURS LODGED AN OBJECTION AGAINST THE RIDER OF MISS QUISQUEYA FOR ALLEGED INTERFERENCE IN THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
