**Footnotes**

NO CALCETINES stalked the early front runners racing near the inside, began to advance position heading into the turn, raced two wide top of the lane, took lead by slight margin in the upper stretch and steadily drew clear. ARTIE OCEAN tracked the early pacesetters, raced two wide in the turn and steadily gained ground in the late stretch. PAPA DOC saved ground racing near the inside, continued bid at the top of the lane and failed to kick in late drive. BACKSEAT MEMORIES reserved racing near the back of rivals along the inside, drifted out in the turn, carried out MY HOT CHILI and had mild gain in the stretch. CANTINERO settled in near the back of rivals and steadily improved position. ZANE passed tiring foes in the stretch. ENDURING CAUSE carried

out wide in the turn by BACKSEAT MEMORIES and had no rally. ANT HILL failed to be a threat. MY HOT CHILI dictated the early pace and steadily faltered entering the turn. LUCKY SHOT raced up close in the early going and steadily faded. FINGIR showed little throughout. JEB'S BREW made a brief bid in the early going and steadily faded after a half.
