Footnotes

FIT AND AWESOME chased the pace three wide, made a run to take over in the stretch, opened a clear lead at the sixteenth pole, then was all out to last over DIXIE SLAM. The latter, unhurried after breaking a step slowly, eased out for the stretch run and rallied to just miss. MY GOLDEN OPINION off a step slowly, was rated off the pace, swung out for the stretch run and had no response when asked. A CENTURIAN set the pace under pressure along the rail into the stretch, then gave way. SPEIGHT THE HALO pressed the pace outside A CENTURIAN into the stretch and tired. BANK OF DAD was not a factor. DOUBLE JUDGE stumbled at the start, saved ground and was done early.
