PERSUADING chased the winner three wide into the stretch but couldn't stay with that rival while clearly second best. LACIE SLEW stalked the leaders three wide to the top of the stretch and tired. MY PAL CHRISY was not a factor. CALLMETHESQUEEZE was outrun.
