DEPUTY DARLING unhurried early, raced five wide around the far turn, rallied to catch ACADEMICIENNE inside the sixteenth pole and won going away. ACADEMICIENNE rated off the pace, angled four wide on the far turn, rallied to take over in midstretch, made the pace to past the sixteenth pole, then couldn't match strides with the winner. SLEWIE JONES reserved racing along the inside, swung out for the stretch run and rallied for the show. GATOR'S TRACKS stalked the pace along the rail into the stretch, then gave way. KELLY'S PIC quickly moved to the fore, made the pace along the rail into the stretch and tired. MORNINGSIDEHEIGHTS failed to menace. MICHELLE'S TRIP was not a factor. MY PRECIOUS BABY tracked the pace, raced three wide around the far turn and faltered. HANNAH'S PRINCESS chased the pace into the stretch, then faded.
