WOODFORD BELLE unhurried after stumbling at the start, saved ground into the stretch the final time, angled out and rallied under pressure to be up late. THISLILSOULOFMINE reserved for a mile, circled rivals four wide around the final turn, moved to gain a slim advantage nearing the eighth pole, maintained that advantage to deep stretch and yielded. SEX APPEAL allowed to settle, rallied three wide to gain the lead on the final turn, made the pace into the stretch and gave way. KATHERN'S KITTEN rated for a mile, rallied to reach contention in the stretch but couldn't sustain her bid. PELEADORA FUERTE failed to menace. STYLE SQUAD was not a factor. RACHEL'S GIRL was outrun. LUCKY AFTERNOON tracked the leader along the inside to the top of the stretch, then tired. SHAHADAROBA quickly moved to the fore, opened a long lead racing under the wire the first time, made the pace along the rail into the final turn, then faded.
