VOCE DEL LEONE unhurried early, eased out in the stretch and closed with a rush to be up in time. FEDERAL EXCHANGE set the pace off the rail, drew clear in the stretch but couldn't resist the winner in the final strides. SHERIFF IRA rated off the pace, raced four wide around the turn and closed with a mild response to be up for the show. BRACKET BUSTER reserved off the pace, advanced three wide around the turn but didn't do enough late. CALL ME SWEETHEART chased the pacesetter into the stretch and gave way. CUNAGUARO chased the pace along the inside around the turn, then tired. COMMANDER TATE was through after a half mile. SIR PHILIP saved ground and never threatened. SURGE POWER was done early. OH SO DEBONAIRE was outrun. LACONIC was no factor after being steadied in the chute.
