CONCERT STAGE set the pace along the inside into the stretch, then was fully extended to hold sway. ROSE BRIER rated off the pace, saved ground and rallied to be up for the place. RUNYON HUMOR reserved off the pace, closed with a mild response while just being edged for the place. VOLCANO RUN tracked the pace off the rail into the stretch but had no response when asked. CYTHEREAN off slowly, failed to menace. NO PLAY was not a factor. FOURSEVENTEEN well placed early, tired. GIBSON COUNTY LINE chased the winner off the rail into the far turn, eased to the inside and faltered. MACHO COACH was not a factor.
