Footnotes

AMBER COAST stalked the early front runners along the inside, urged between rivals heading into the far turn, raced three wide in the stretch, dug in late and prevailed under driving finish. JAMESTOWN tracked the early pacesetter, edged up to the lead heading into the turn, took lead by a slight margin, continued to dig in and could not hold off AMBER COAST in final strides. CONSERVE stalked the early front runners, began to advance to the lead heading into the far turn, vied at the top of the lane with JAMESTOWN and could not sustain bid in late drive. RESPONSIVE EYE settled in early going, began to advance position along the outside of rivals nearing the turn, raced five wide at the top of the stretch, gained position and had no final kick. ACT OF WAR (IRE) reserved in the early going, raced two wide in the stretch and slightly improved position. BARBADA allowed to settle in early going, raced two to three wide top of the lane and finished evenly in late drive. WISE MAKER raced in the back of the pack early, continued two wide in the stretch and failed to be a threat. BABY MAXWELL made a bid between rivals in the backstretch, angled out in the lane and lacked late response. FRANKIE AND JOE took command in opening stages and gave way nearing the turn, vanned off. EGOLYAN raced up close in the opening quarter and was pulled up at the top of the stretch.
