SCEALEILE stalked along the inside in opening stages, began to advance four wide in the far turn, edged up to lead at top of the lane and drifted out in the late stretch, disqualified from first placed behind GINNY'S GREY. PEEKYTOES raced up close tracking the top two front runners, began to advance position entering the far turn, raced two to three wide in the stretch and continued to dig to the wire. GINNY'S GREY reserved along the inside in the early going, steadily advanced position in backstretch, raced four wide in the turn, continued to dig in five wide in drive, forced to briefly lose momentum in the late stretch. INCLUDE THE AUSSIE lacked speed in the early going and raced in the back of the pack, began to advance position heading into the far turn and quickly gained ground in the stretch. FANCY'S FIRST stalked two wide in the backstretch and continued evenly in the stretch. HELLUVA HUNCH reserved in the early going, continued to race in the back of the pack in the backstretch and began to gain ground in the stretch. ABENI made a two to three wide bid heading into the turn and had nothing left in the stretch. SWEETLY PUT vied for the early lead with KILLIN THEM SOFTLY and had nothing left heading into the far turn. DREAMCASTLE raced evenly two to three wide and failed to menace. KILLIN THEM SOFTLY vied for the early lead with SWEETLY PUT, continued up close and began to fade in the upper stretch. TRAIL ROCKIN failed to be a threat. AFTER STEWARDS INQUIRY AND OBJECTION BY RIDER ON GINNY'S GREY STEWARDS DISQUALIFIED SCEALEILE FROM FIRST AND PLACED THIRD FOR INTERFERENCE IN THE LATE STRETCH
