Footnotes

GOLD POLICY chased the pace three wide, bumped with HALF WED in early stretch, rallied to gain the lead inside the sixteenth pole, then just lasted over TIZNOW MYTIME. The latter, unhurried early, angled out on the turn, then rallied to just miss. LAWYER JIM outrun after stumbling at the start and being steadied from tight quarters soon after, swung out for the stretch run and closed well to be just up for the show. DIDN'T TAKE IT chased the pace three wide, rallied to take over on the turn, made the pace to just inside the sixteenth pole, then yielded. HALF WED reserved racing along the inside, eased out while advancing leaving the turn, then bumped with GOLD POLICY in early stretch and couldn't gain late. CABEUS chased the pace along the inside, moved to gain a slim lead racing into the turn, maintained that advantage to nearing the quarter pole, then tired. MINESTONE raced four wide and faltered. SNOOTY was through early. MAORI was outrun. CHYHYRYN showed speed off the rail into the turn and faded. GALILEE was done early and pulled up in the stretch.
