Footnotes

HEARTS OF RED stalked the pace, rallied inside MANDA BAY to gain the lead just inside the eighth pole, then was all out to prevail. CERTAINTY reserved off the pace, angled five wide on the far turn, then rallied to be up for the place. CUTIE'S ROSIE rated off the pace, rallied to loom a threat in midstretch but couldn't sustain her bid. MANDA BAY stalked the pace, moved to take over leaving the far turn, made the pace to the eighth pole, then weakened. MOLLY MORGAN stalked the pace, angled four wide on the far turn, made a run to reach contention in midstretch, then gave way. MISS AMELIA allowed to settle, raced in striking position into the stretch but had no late response. WICKED LADY failed to menace. WILDLY D 'LICIOUS tracked the pace along the inside to nearing the stretch, then tired. GIFT WRAP was not a factor. SWAKOPMUND vied for the lead along the inside to past midway of the far turn, then faltered. GOOD MOTHER FRAN vied for the lead outside SWAKOPMUND to past midway of the far turn and faded.
