Footnotes

PAPAW BODIE stalked the pace three wide, rallied to take over nearing the eighth pole, then was fully extended to hold SOLITAIRE safe. The latter, reserved for a mile, eased out to race four wide around the final turn, then rallied to be up for the place. NEWSADAD unhurried for a mile, eased out to race five wide around the final turn, then rallied while being edged for the place. SIERRA ALPHA (GB) stalked the pace along the rail into the stretch the final time but didn't do enough late. ADIRONDACK SUMMER tracked the pace three wide, moved up to loom a threat in midstretch but couldn't gain late. SYROS vied for the lead outside TWINSPIRED into the stretch the final time and weakened. DEAL MAKING well placed into the stretch the final time, lacked a rally. SEASIDE RETREAT stalked the pace, then gave way in the drive. GROOVY SOUL was not a factor. TWINSPIRED stumbled at the start, vied for the lead along the inside into the stretch the final time, then tired. CALLINGAHARDTEN allowed to settle, advanced four wide around the final turn, then faltered in drive.
