SONIC CHARM stalked the pace, gave chase but unable to gain, then weakened in the stretch. AIR MAGGY was outrun. BARON VON RUCKUS raced in third the first circuit, tired and dropped back. FINAL STRAW was rated, moved forward on backstretch the final circuit, then tired and fell two fences from the finish.
