NEVILL'S MISTAKE was rushed to the lead and set the pace then drifted out in the stretch and held on. JOHNNY CADILLAC raced in the second flight then angled out and was brushed in the stretch and just missed. JOY FROM PHOENIX showed no speed then angled out and closed willingly while five wide. WATCH PAT was void of speed and ducked in at the top of the stretch then made a mild rally. BANNING was allowed to settle and saved ground then took up at the top of the stretch. SABONA'S TRYST raced in the middle of the pack, made a five wide bid and faltered. UP SUGAR CREEK was rushed to contend, flashed brief foot and faltered. (FOLLOWING A CLAIM OF FOUL BY THE RIDER OS JOHNNY CADILLAC AGAINST NEVILL'S MISTAKE AND A CLAIM OF FOUL BY THE TRAINER OF BANNING AGAINST WATCH PAT, NO ACTION WAS TAKEN ON EITHER INCIDENT IN THE STRETCH)
