### Footnotes

GIRLS CHOICE vied for command along the rail from the outset, turned back a challenge between calls in the final furlong and edged forward late under steady pressure. BRAVE YANK joined the pace four wide in the opening furlong, pressed for command three deep nearing upper stretch, gained the lead between calls past the furlong marker but was outfinished. DAKOTA MILKSHAKE, a step slow into stride, recovered contention racing to the bend between foes, angled to the rail on the turn and was making steady progress late. LO ME led the second flight off the inside early, angled inwards a bit on the turn, shifted out to bid four wide nearing upper stretch but lacked the needed final kick. ZIZI CAT tracked the leaders four wide in second flight and continued evenly in that path to late stages. STAR RATING broke awkwardly, lost position to the field and passed some tiring rivals. FRANKLIN COUNTY, shuffled back out of tight quarters while under pressure to contend in the opening quarter, steadily faded on the turn. SWAGGER LEE was urged to dispute the pace between foes racing into the bend and gave way in upper stretch. IKAROS never seriously menaced. A P GOLDENBOY broke slowly and trailed throughout.
