WILDCATA set the pace from off the rail while pressed and edged clear in the run to the wire. ROOVILLE raced close up off the rail but could not go with the winner in the drive. SEVEN GOLD GEMS lacked speed off the rail and rallied belatedly for a share. LADY ANNA J saved ground and came up the rail with a mild bid. LUNA SEA pressed the pace from the inside and tired. SENSUOUS CINNAMON made a three wide bid on the turn and faltered. CLEARCREEKDELIGHT raced four wide and gave way.
