FLYING ACT broke sharply, disputed the pace between foes racing into the bend, gained a narrow advantage after a half while angling to the rail, edged clear and widened his margin late under steady pressure. SORROWFUL JONES joined the pace outside foes from the break, pressed the pace three deep racing into the turn but couldn't match the winner late. COLE B tracked the leaders unhurried off the inside from a bit out of striking distance early, continued three deep into upper stretch, angled to the inside in the final sixteenth and continued willingly for a share. READY TO ROMP tracked just off and outside the first flight, raced four wide on the turn while gaining striking distance, drifted out nearing upper stretch and had no final response. R T'S BLACK CAT was settled along the inside in early stages and steadily improved his position inside foes racing into the stretch. CELTIC EXPRESS tracked the leaders along the rail from out of striking distance early and offered no closing response. JOSIES DISTRACTION broke slowly, settled into stride and passed between tiring rivals racing into the stretch. WEWEWEALLDWAYHOME was settled off the pace racing five deep early, continued in that path into upper stretch and proved no factor. COURT COMPOSER settled outside foes four deep early, was fanned six wide into upper but was never a factor. PROSPECT ROAD settled three deep between rivals in the opening quarter and never mounted a serious challenge. MILLO'S PARADISE was hustled to the front along the

inside but was spent after a half.
