PENTS BRIDE raced close inside, angled out and rallied for the place while not a threat. MS. SPEEDO raced near the middle of the field, angled out and rallied belatedly for a share. LAVENDER LACE steadily improved her position. UTOPIAN SPLASH failed to reach a contending position. SOUTHERN MISS set the pace from just outside while pressed and tired. SENSORIOUS KISS lacked speed and showed little. HER AND HIM broke slowly and was outrun. CHEQUERTICKET gave way.
