**Footnotes**

PECOSA sprinted clear of her foes near the inside soon after the break, dictated the pace on a clear margin into upper stretch and held sway to the end while being kept to steady encouragement. BELLA'S CASTLE tracked the pacesetter in second flight nearest the rail, raced in close quarters leaving midstretch while exchanging some contact with KITTY COVENANT but continued with interest to edge a rival for second at the wire. TAWDRY chased the pacesetter three deep into the bend, continued as part of the second flight in that path into upper stretch, drifted inwards nearing the sixteenth marker bumping, then clipping KITTY COVENANT and was outfinished for place honors. LOVE TRIAL, forwardly placed four wide in the opening stages, pressed the issue in that path on the bend and gave way in upper stretch. MS. BIRD WATCH was settled outside the leaders in the opening stages but offered no rally. KITTY COVENANT reserved out of close quarters racing just off the second flight in the opening stages, split foes racing into upper stretch, was bumped, then clipped heels with TAWDRY when caught in tight quarters approaching the sixteenth marker and fell, losing her rider. FOLLOWING THE RACE THE STEWARDS CONDUCTED AN INQUIRY INTO THE STRETCH RUN AND DISQUALIFIED TAWDRY FOR INTERFERENCE, PLACING HER LAST.
