Footnotes

L. B. EXPRESS was urged to secure a forward placing racing five deep in the opening stages, made steady progress racing into the bend to advance three deep on the pacesetter, wrested command from that foe in upper stretch and went clear under firm handling. BLUSHING PREACHER, bumped at the start, was quickly corrected to track off the second flight outside foes, continued with interest four deep into upper stretch and prevailed for place honors in late stages. BOOT TAILS broke outwards bumping a rival, was settled into stride, switched outside foes to race six wide leaving the turn and continued willingly in that path to earn a share. BIGTIME MAC broke outwards bumping HYDROPLANE, was righted to gain a forward placing between foes, shook clear after the opening furlong to set the pace along the rail, resisted the winner's challenge briefly nearing upper stretch but failed to sustain his momentum. HYDROPLANE, bumped at the start, shifted into the path of BLUSHING PREACHER, was quickly collected to chase the pacesetter between foes racing into the turn, dueled for command to upper stretch and faded in the last furlong. DOONEY ROCK broke slowly, settled into stride, then passed between tiring rivals in late stages. MR. ALANZO, forwardly placed while angling to the inside, tracked just off the pacesetter racing into the turn and steadily faded nearing upper stretch. KONA KID was never a factor. APACHE CREEK tracked the pace unhurried off the second flight between foes near the inside racing into the bend but couldn't produce the needed closing bid. B SHARP tracked off the second flight along the rail in the opening quarter, was held up out of

tight quarters entering the bend and soon dropped out.
