**Footnotes**

SAVY'S DELITE broke slowly, split foes in the opening furlong to gain position in the second flight off the inside, made steady progress to gain terms with the first flight on the bend, split foes just off the inside in upper stretch, then drew clear under firm encouragement in the final furlong. SONGANDDANCELADY, reserved in hand while five wide in the opening stages, made steady progress four wide racing into upper stretch and continued in that path to secure the place late. MAXY LEVENS, close up three wide in the opening stages, pressed the pace in that path into upper stretch but couldn't match the winner's bid, weakening in the last furlong. HOLE IN ONE was urged to dispute the pace along the rail, dueled for command into upper stretch and gave way in the last furlong. SECA TREACE ducked out sharply at the start, was quickly righted to duel for command between foes and gave way leaving the furlong marker. WINDS DUE EAST tracked the leaders unhurried off the inside racing to the bend, angled four wide entering upper stretch and continued evenly. DALEEN'S DESIRE was never a factor. MORE THE MARI'ER was guided to the rail soon after the start but steadily retreated from contention nearing the lane. DUE TO A TIMER MALFUNCTION THE RACE WAS HAND TIMED.
