NO RACHMONES was urged to dispute the pace along the rail from the outset, continued in an extended skirmish for command while shifting off the inside racing past the quarter mile marker, gained a narrow advantage midstretch, then shifted inwards under right handed pressure bumping DAKOTA MAC in the final sixteenth while narrowly containing that foe. The latter raced three deep off the first flight in the opening stages, was guided to the inside in the second furlong to track the leaders along the rail, came through inside foes to challenge when presented an opening nearing midstretch, then continued with a grudging effort while being steadied slightly when being bumped soundly and hitting the rail in late stages. DELSTAR shifted out bumping COLLIN'S SMILE, was roused to dispute the pace outside a rival racing into the bend, dueled for command into upper stretch and weakened when failing to match the top pair late. BELVEDERE ROAD tracked just off the first flight three deep in the opening stages, was urged to challenge in that path nearing upper stretch but weakened leaving the furlong marker. COLLIN'S SMILE, bumped at the start, settled in last a bit off the inside racing into the bend, shifted out four wide in upper stretch but made no impression on the leaders. FOLLOWING THE RACE THE RIDER OF DAKOTA MAC LODGED A CLAIM OF FOUL AGAINST THE RIDER OF NO RACHMONES AND THE STEWARDS CONDUCTED A CONCURRENT INQUIRY. AFTER REVIEWING THE INCIDENT IN THE STRETCH THE STEWARDS DISQUALIFIED NO RACHMONES FOR INTERFERENCE, PLACING HIM SECOND.
