MISTY MIRANDA, in touch with the leaders in the opening stages, dropped off the first flight to track those foes from just out of striking distance racing outside a rival in the second furlong, continued with a steady advance while shifting out four wide racing into upper stretch and produced a solid late response to wrest command in time under firm handling. BEEWAY broke inwards bumping I O CASHEL, was quickly righted, then urged to dispute the pace along the rail racing into the bend, edged away to a clear advantage nearing the furlong marker but couldn't quite fend off the winner. SO LONG FOR NOW joined the pace three deep soon after the start, pressed the issue in that path on the turn into upper stretch and weakened late. CONCEAL N CARRY tracked off the second flight outside foes in the opening stages, made some progress to gain contention while being fanned five wide racing into upper stretch but finished evenly in the closing stages. I O CASHEL, bumped at the start, tracked the leaders along the inside in second flight, saved ground to upper stretch but lacked the needed closing bid. PERFECT AMY was never a factor. CRESCENT COURT was urged to dispute the pace between foes from the outset racing into the bend and gave way after a half.
