Footnotes

APACHE STORM settled off the second flight racing four deep to the backstretch, continued widest to the far turn, circled foes racing six wide into upper stretch to gain striking distance and just edged BIG BEAR HUG in the final strides under strong handling. The latter, held up off the second flight while off the inside in the opening half, commenced a steady advance four deep on the far turn to challenge in that path entering upper stretch, gained the lead leaving the furlong marker and just failed to contain the winner. GUT KING tracked the leaders in second flight between foes in the opening half, split rivals to challenge three deep in upper stretch, resisted the top pair to late stages and was narrowly outfinished. SIR REDFORD settled off the second flight racing three deep early, shifted out on the far turn to challenge five wide between rivals nearing upper stretch and came through close quarters to continue with a mild bid. LIGHTHOUSE JUDGE moved to the fore racing well off the inside on the first turn, went well clear on the far turn while angling to the inside but emptied out once headed in upper stretch. SHOW YOUR FACE tracked off the second flight along the inside in the opening half, saved ground to upper stretch but offered no rally. FAST PROMISES was settled along the inside in the opening half, shifted out while making some progress on the far turn, steadied a bit in traffic nearing upper stretch, angled to the rail racing through the stretch but never seriously menaced. COUNT DE BARAN, allowed to settle well off the field racing to the backstretch, never gained contention. JUNGLE HEART, caught four wide while urged to a forward placing racing to the backstretch, emptied out early. DOLLAR FACTOR tracked just off the pacesetter along the inside in the opening half but steadily retreated along the rail nearing upper stretch.
