APPLE G pressed the pace, challenged in the stretch, came in a bit to bump LEITH LAKE near the eighth pole then prevailed in a hard drive. The latter set the pace from the inside, was bumped by the winner in the stretch and battled gamely but missed. REALLYAROAN raced close up but lacked a winning bid. WHIRLYBIRD also failed to rally. WOODY N JUNE was not a factor. MONEY CLIP and O K BUT HOWABOUTME were always outrun. THE TRAINER OF LEITH LAKE LODGED A CLAIM OF FOUL AGAINST APPLE G ALLEGING INTERFERENCE IN THE STRETCH BUT IT WAS NOT ALLOWED.
