RIVER BEAR was settled into stride along the inside in the opening quarter, commenced a steady advance to striking position midway through the bend, shifted out to split foes just off the inside entering upper stretch challenging inside the pacesetter, then wrested command and kicked clear late under firm left handed encouragement. SIGNSEALNDELIVER was held up off the first flight from just out of striking distance outside rivals racing to the turn, continued with a steady advance while shifting out five wide racing into upper stretch, then continued with a steady effort in that path to late stages to prevail for second. KIND REGARDS, in close attendance to the pace three deep from the outset, moved to force the issue in that path racing into upper stretch, struck the front nearing the furlong marker but lacked the needed final kick to fend off the top pair. CONCHACER, on terms with the first flight from the break, attended the pace between foes in the opening quarter, pressed the issue between foes racing through the turn to gain a narrow advantage after a half but weakened nearing midstretch. FOUR LEFT FEET, off last, recovered to make brief progress four deep between foes to challenge after a half but flattened out in upper stretch. SAINT LEON moved to the fore along the inside from the break, dueled for command along the rail through the turn and gave way entering upper stretch.
