BUD'S LADY forwardly placed, advanced on the turn, came out and bumped CART'S LINDA twice approaching the quarter mile marker, rallied and held sway late. CART'S LINDA broke outwardly, stalked the pace, was bumped soundly at the quarter mile marker and stayed on through the stretch run. KIP BERRIES gained the early lead, was headed leaving the turn and yielded. STIVERS SUPRISE saved ground to no avail. SOUTHERN WONDER was always outrun. FOLLOWING THE RACE, THE RIDER OF CART'S LINDA LODGED AN OBJECTION AGAINST THE RIDER OF BUD'S LADY ALLEGING INTERFERENCE. AFTER REVIEWING VIDEOTAPED REPLAYS, THE STEWARDS DISQUALIFIED BUD'S LADY AND PLACED HER SECOND.
