DEFUHR set the pace from the inside on a clear lead and drew off in the stretch under a brisk hand ride. ZITLALY raced off the rail near the middle of the field and rallied for the place while no match for the winner. KISSIN BEAUTY lacked speed, angled out for the drive and gained belatedly. WHY NOT WHITNEY made a mild bid in the stretch and flattened out. WRETCHED EXCESS was fractious in the gate, raced close up inside and weakened. SHE WHO DANCES was never a factor. RUSH CREEK passed tired ones in the drive. ANGELA'S PRIDE was fractious in the gate, stalked the pace just outside and tired. JET CAR gave way in the drive. BUTTERCUP EXPRESS was always outrun. JUDGE J B was fractious in the gate and gave way in the drive.
