### Footnotes

CACTUS TOWN seized command at once, held well into the stretch and pulled away under a drive. LOGAN'SSHOREBREEZE stalked the pace three wide, was outpaced into the stretch but stayed on to secure the place spot. ARCH'S ARROW reserved while four wide, remained four wide into the stretch and had no rally. HELICOPTER broke outwardly, settled while five wide, continued five wide into the stretch and made no contending bid. FROSTYBDANCING saved ground and faded. CAMARADERIE never menaced.
