**Footnotes**

LAWN, forwardly placed along the inside racing into the first turn, relinquished the lead to a rival on the backstretch, shifted outside that foe while making steady progress to regain terms entering the far turn, wrested command entering upper stretch and held sway to the end under firm handling. FIRST OF FEBRUARY angled inwards after breaking a step behind the leaders while brushing AVA MAE and herding that rival inward a bit racing to the first turn, tracked outside a rival in second flight racing to the far turn, continued with a steady, three wide advance entering upper stretch but was always only second best. BIG SISTER stalked just off the pacesetter racing into the first turn, took over from that foe entering the backstretch, dictated the pace into the far turn but couldn't sustain her momentum. SERNA'S GOLD, reserved off the inside in early stages, made some mild progress to improve her placing in the last quarter. AVA MAE, herded inwards a bit after the start, switched out to make a brief bid outside foes nearing the far turn but came up empty in the drive. CLASSIFIED BLUES was held up just off the leaders along the inside stalking the pace but steadily retreated from contention on the far turn. SYND, reserved saving ground in the opening stages, soon dropped out.
