### Footnotes

SEGURO was settled three deep in the last flight racing to the backstretch, commenced a steady advance while shifting out entering the far turn, circled foes five wide racing into upper stretch, took charge and was taken in hand late once the issue was decided. MANO POINT, forwardly placed along the inside racing into the first turn, was reserved from striking distance in the opening half, made a steady advance to contention along the rail racing into upper stretch, couldn't match terms with the winner but proved best of the others. FIRE CLOUD settled along the inside in the last flight racing to the backstretch, shifted off the rail nearing upper stretch, angled outside a tiring foe nearing the furlong marker to race four deep and continued with interest to gain a share. RULER OF THE COURT tracked the pacesetter from out of striking distance racing well off the inside into the backstretch, continued four deep into the second bend while making a brief advance but lacked the needed final response. KETTLE CORN settled between foes racing to the backstretch and never mounted a serious challenge. UNO PECADOR was hustled clear into the first turn, opened a commanding margin racing through the backstretch and gave way abruptly entering upper stretch.
