Footnotes

AFLEET ABACO settled into stride along the rail while dropping well off the leaders racing into the backstretch, steadily gathered momentum entering the second bend while shifting off the inside, swung five wide entering upper stretch while being roused to advance, shifted inwards under pressure racing through the lane but just edged ZIPPY TRIP in the final strides. The latter, a bit reluctant to load in the gate, sped to the fore along the rail racing to the first turn, set the pace on a narrow margin into the far turn, resisted several challengers to maintain the advantage past midstretch and just failed to contain the winner. FEATHERINTHEBREEZE tracked the pacesetter three deep in second flight racing to the backstretch, moved to challenge in that path on the far turn but flattened out racing through the stretch. ABBY'S SLEW tracked off the second flight in the opening half, shifted out four wide nearing upper stretch while being urged to advance but had no final response. CASSIDILLY, urged to secure a forward placing while shifting in on the first turn, tracked the pacesetter between foes into the second bend, made a brief bid between foes on the far turn, couldn't maintain terms with the pacesetter, then altered course avoiding tight quarters in late stages. SAINT PATTY ANN was settled into stride off the inside racing to the backstretch and never gained contention. MS FOUREIGHTWONINE, reserved off the second flight outside foes early, never mounted a serious challenge. SWEET COOL tracked just off the pacesetter along the inside to the second bend and steadily faded racing through the far turn. CHICKEN JUICE, caught four wide racing into the first turn, dropped out early.
