**Footnotes**

TAXES joined the pace between foes from the outset, pressed the issue outside a rival into upper stretch, edged forward nearing the furlong marker and held sway to the end under firm right handed encouragement. JUICE PLUS, prominent three wide between foes in the opening stages, continued with a steady effort in that path to the end to close the gap. CHATFIELDS CHAP disputed the pace from the break while shifting a bit off the inside, dueled for command into upper stretch and weakened nearing the furlong marker. HE'S BORN TO RUN swerved out at the start, was righted to track off the first flight five wide early, shifted inwards a bit on the turn, then shifted back to the five path in the last quarter while continuing evenly. DAKOTA'S COURT settled near the inside in the last flight early, shifted outside a rival entering the turn and continued evenly between foes into the stretch. STATE PARK was settled between foes in the last flight early, angled six wide racing into upper stretch but made no impression. BIG MAN HUNGATE tracked just off the first flight four wide in the opening stages, angled to the rail nearing the turn and steadily faded entering upper stretch. WESTERN ZEN was settled outside foes in the last flight, angled to the rail entering the turn and never seriously menaced.
