### Footnotes

RECTOR broke a bit awkwardly, was settled off the second flight racing into the backstretch, commenced a steady advance on the far turn, shifted out four wide in upper stretch and produced a sustained response to narrowly prevail under firm handling. LEMON CUSTARD broke readily, was held up just off the first flight stalking those foes under light rating in the opening half, came through nearest the rail to challenge when presented an opening leaving the quarter mile marker, gained a narrow advantage midstretch but just failed to contain the winner. FACE THE FIRE, forwardly placed three deep racing into the first turn, was eased off the leaders to track those foes outside a rival in the second flight on the backstretch, moved to challenge three deep entering the far turn, was carried out a bit by HOUSE OF USHER leaving the far turn but continued willingly between foes to gain a share while no match for the top pair. HOUSE OF USHER moved to the fore along the inside racing into the first turn to dictate the pace on a narrow margin, dueled for command racing into the far turn, shifted off the inside nearing upper stretch making light contact with FACE THE FIRE, weakened leaving the furlong marker and was being gathered up approaching the wire. WEGGIE reserved along the inside from well out of striking distance in the opening half, continued along the inside while under pressure to advance on the far turn and made some mild progress racing into the stretch. JACK AND MAX went up from the break to prompt the pace outside a rival into the backstretch but gave way abruptly when failing to match terms with that foe entering the far turn.
