STAKES Indian Maid H. Listed - Thoroughbred

FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD. By subscription of \$100 each, which shall accompany the nomination. A supplementary nomination of \$2,000 may be made on Saturday, September 29, which includes entry and starting fees. Original nominees to pay \$500 to pass the entry box and \$500 additional to start, with \$100,000 Guaranteed: the purse will be divided 60 percent to the winning owner, 20 percent to second, 10 percent to third, 5 percent to fourth, 3 percent to fifth and 2 percent divided equally among the remaining finishers. A trophy will be awarded to the winning owner. Weights: Sunday, September 30, 2012. This Stake will be limited to twelve starters. High weights (including scale of weights) will be preferred, except different owners have equal draw according to weights and second weighted parts of same owner entry receive no consideration over single entries. Failure to draw into the race will cancel all fees, with the exception of nomination fees. In the event of an over-subscribed field, low weighted horses preference will be determined by highest career earnings. Nominations closed Wednesday, September 26, 2012 with 27. (Rail at 10 feet).

Footnotes

ROMACACA moved to the fore while shifting a bit off the inside racing to the first turn, dictated the pace on a comfortable margin on her own courage into the far turn and held sway to the end under steady handling. JULIE'S LOVE (GB) broke readily to gain a forward placing, stalked the pacesetter under rating in the opening half, was urged to challenge the leader nearing upper stretch but was always only second best. KEPI tracked the leaders unhurried three deep in the second flight in the opening stages, was urged to challenge in that path racing into upper stretch and prevailed narrowly for a share. AFFAIR DABBLER settled in last off the inside racing to the backstretch, split foes three wide racing through the stretch and made some belated progress. FOREST UPROAR settled off the second flight outside a rival racing to the far turn, shifted out wide in upper stretch while being urged to advance but finished evenly late. MOURETTE tracked the pacesetter inside foes in the second flight racing to the far turn but offered no closing response. MAUDE S tracked off the second flight near the inside racing to the far turn but never mounted a serious challenge. RUTHVILLE reserved between foes in the second flight racing to the far turn, steadily retreated entering the stretch.
