STAKES Robert F. Carey Memorial H. Listed - Thoroughbred

FOR THREE YEAR OLDS AND UPWARD. By subscription of \$100 each, which shall accompany the nomination. A supplementary nomination of \$2,000 may be made on Saturday, September 29, which includes entry and starting fees. Original nominees to pay \$500 to pass the entry box and \$500 additional to start, with \$100,000 Guaranteed: the purse will be divided 60 percent to the winning owner, 20 percent to second, 10 percent to third, 5 percent to fourth, 3 percent to fifth and 2 percent divided equally among the remaining finishers. A trophy will be awarded to the winning owner. Weights: Sunday, September 30, 2012. This stake will be limited to twelve starters. High weights (including scale of weights and sex allowance) will be preferred, except different owners have equal draw according to weights and second weighted parts of same owner entry receive no consideration over single entries. Failure to draw into race will cancel all fees, with the exception of nomination fees. In the event of an over-subscribed field, low weighted horses preference will be determined by highest career earnings. Nominations closed Wednesday, September 26, 2012 with 21. (Rail at 10 feet).

**Footnotes**

SUNTRACER was settled in last racing to the backstretch, shifted out nearing the far turn gathering momentum, swung out to the six path in upper stretch, shifted inwards under pressure but narrowly prevailed in time under brisk handling. NIKKI'S SANDCASTLE, reserved between foes from just out of striking distance in the opening half, steadily drew into contention while shifting out four wide leaving the far turn, moved to challenge between foes in that path,

struck the front between calls late while resisting grudgingly to the end but just failed to contain the winner. TAZZ, pulling a bit along the inside while being rated just off the first flight racing to the backstretch, shifted out three deep on the second bend while moving to challenge, disputed the issue inside the top pair past midstretch in a game effort and was just outfinished. HOTEK was rated saving ground in the opening half, came around a tiring foe to bid between rivals in upper stretch but lacked the needed final kick. CHEROKEE LORD, pulling a bit in early stages while gaining terms on the pace, prompted the pace between foes into the far turn but failed to sustain his effort nearing midstretch. MYSTIC, reserved near the inside in the last flight racing to the far turn, was steadied while being bumped nearing midstretch and offered no rally. MOONSHINE MULLIN, forwardly placed three deep in the opening stages, gave way racing through the far turn. RATATAT moved to the fore along the rail racing to the backstretch, dueled for command into the far turn and gave way abruptly nearing upper stretch. FINAL COUNT tracked the leaders three deep from out of striking distance racing to the far turn and had no closing response.
