GHOST ON THE RUN, reserved in last a bit off the inside racing to the backstretch, steadily drew into contention while shifting outside foes on the far turn, swung six wide in upper stretch and produced a steady late response to prevail in time under firm handling. APPELLA'S WONDER, reserved saving ground in the opening half, shifted out on the far turn, was roused to challenge five deep between foes in upper stretch, struck the front between calls late and just failed to contain the winner. DREAMS DIE FIRST tracked off the second flight outside a rival in the opening half, circled foes five wide on the far turn to gain a clear advantage in upper stretch but failed to sustain her momentum. SING IT OUT, bumped at the start, was urged to dictate the pace along the inside racing to the far turn, produced a second effort after being headed nearing upper stretch and continued under pressure four deep to late stages. SOMALI BYRD was rated along the rail tracking just off the first flight, continued under reserve when shuffled back in close quarters racing through the far turn and couldn't menace further. NORTHERN SWALLOW was rated between foes in the second flight in the opening stages, shifted out four wide on the far turn while being urged to advance but had no closing bid. DANI NIKKI, caught four wide racing into the first turn while being rated off the first flight, was urged to challenge three deep nearing the far turn but came up empty nearing midstretch. PRETTY PENELOPE, bumped at the start, was urged to join the pace outside a rival racing to the backstretch, pressed the issue between foes to strike the front on the far turn but emptied out leaving midstretch.
