Footnotes

FORTHELOVEOFMONEY tracked the pace unhurried between foes in the opening stages, shifted outside foes entering the bend while making steady progress to gain striking distance, was fanned six wide nearing upper stretch while moving to terms with the first flight, drifted inwards under pressure while momentarily impeding several foes but continued with a sustained response to prevail under brisk handling. NICCET was urged to secure terms with a rival on the lead along the inside, attended the pace under some reserve racing into the bend, shook clear entering upper stretch but proved only second best when confronted by the winner. SCARLET TEE tracked off the second flight five wide early, made steady progress four wide between foes on the bend, lodged a bid five deep between foes entering upper stretch, was forced inwards by the eventual winner nearing midstretch but continued with interest to just miss the place. LOVE THAT KITTEN was urged to position between foes in the second flight, split foes three wide in upper stretch to challenge but lacked the needed final bid. CATAGUSKA, bumped soundly at the start, was righted, then urged to contend three deep between foes, checked out of close quarters nearing the turn, was urged to challenge between foes four deep racing in tight quarters nearing the quarter mile marker, shifted five wide in upper stretch and had no further response. HIGH BROW HONEY tracked the leaders off the second flight along the inside, saved ground to upper stretch and passed inside tiring rivals. SIN BIN settled off the inside early and never gained striking distance. CROSSWISE, prominent four wide in the opening stages, bid for command racing three deep on the turn, was caught in tight quarters leaving the quarter mile marker and proved empty in the drive. LAST STOP was

urged to dispute the pace between foes from the break, dueled for command into upper stretch and gave way. RAISINABOVEONLY was a brief factor along the inside but emptied out early. FOLLOWING THE RACE THE RIDER OF SCARLET TEE LODGED A CLAIM OF FOUL AGAINST THE WINNER WHICH WAS DISALLOWED.
