Footnotes

BRUTAL ATTACK was carried out in the first turn, drew off and was shown the whip. LEAD ON race wide into the first turn, dropped back then rallied between horses. MY PRIVILEGED was fractious in the gate and had a late rally. TONY TERRIFIC was taken up early to avoid a fallen horse then rallied late in the stretch. ASHLEYS IRISH LADD was slow early, swung wide in the second turn and had a mild rally. SAN SABA had inside speed and gave way. SEA GAZE broke in the air and passed tiring rivals. FEUDAL CAT was taken up to avoid a fallen horse on the backstretch, made a middle move and no

rally. LIGHTHOUSE JUDGE bore out in the first turn, had the first lead then stopped between horses. HOUSE OF USHER had good early speed and flattened out. FOREST FEVER was through early and widest in the stretch. AWKWARD MOMENT raced mid pack and fell on the backstretch. THERE WAS A STEWARD'S INQUIRY FOR THE RUN ON THE BACKSTRETCH BUT NO ACTION WAS TAKEN.
