GOTTA BELIEVE ME grabbed the early lead, responded into the stretch and bounded clear under token right-handed encouragement. EUROSTEEL reserved early, swung four wide into the stretch, angled in at the three-sixteenths marker and rallied. BRADY MIESTER saved ground, commenced a bid around the far turn, continued inside for the stretch run and produced a mild bid. SHOW YOUR FACE raced forwardly while four wide, continued four wide into the stretch and was outfinished. RULER OF THE COURT broke outwardly, stalked the pace, moved three wide into the stretch and weakened. ROSCOE'S ROCKET passed tired ones. OURAGANS ROAR failed to menace. DA MULE chased the pace while four wide early and dropped back. YONA TORY faltered.
