Footnotes

SIDESPLITTING, reserved off the second flight while shifting nearer to the inside in the opening stages, steadily drew into striking distance nearing upper stretch, angled to the rail splitting foes leaving the quarter marker, came through inside foes to challenge for command near midstretch, gained a narrow advantage and drove clear. WHISPERING BREEZE, reserved outside foes in the second flight in the opening stages, moved to challenge four deep in tandem with several foes nearing upper stretch, continued to dispute the issue outside the eventual winner past midstretch but couldn't quite match terms with that foe late. HEART DOCTOR, forced out by SKIPPY DUDE at the start, settled into stride, angled six wide racing into upper stretch and produced a belated response to earn a share on the wire. TAXES tracked the pacesetter just off the inside leading the second flight into the turn, continued with a steady bid to challenge in tandem with several foes nearing upper stretch but flattened out nearing the furlong marker. FALCON POINT tracked the pacesetter between foes in the second flight, moved to challenge three deep between foes approaching the quarter mile marker but quickly emptied out. SKIPPY DUDE swerved out at the start impeding HEART DOCTOR, was settled off the inside and never gained contention. FLAMING AFFAIR broke outwards bumping SOUL OF A SAMURAI, was righted to track the leaders near the inside but never mounted a serious challenge. SOUL OF A SAMURAI, bumped at the start, was quickly righted then hustled clear along the inside, set the pace into the bend on a clear margin but was spent after a half. SEARCH NO MORE, going a bit erratically early, bolted racing into the turn, was soon outdistanced, then walked off the course under his own power.
