Footnotes

BROKEN AERO moved to the fore along the inside soon after the start, dictated the pace on a narrow margin along the inside to the far turn, shifted out entering upper stretch and responded to brisk handling to draw clear late. DUKE OF DEL REY angled inwards in the opening stages gaining a position just off the first flight, continued with a steady, three wide advance racing into the far turn to challenge but proved only second best in the drive. FRANKLIN COUNTY, bumped at the break, was reserved off the second flight along the inside racing to the far turn, shifted out five deep racing through the stretch but continued with interest to improve position while prevailing for a share. OH MY TODD, urged to secure a forward placing between foes racing into the first turn, prompted the leader racing into the far turn while between foes but faded leaving midstretch. BOSS ALLEY was steadied avoiding close quarters in the opening stages, was caught a bit wide tracking off the second flight racing to the backstretch, was urged to advance while being fanned six wide into the stretch and lacked the needed final kick. BLUE LASER tracked off the second flight between foes in the opening stages, dropped out to last on the far turn, then was roused between foes in upper stretch to improve position with a second effort late. PREOCCUPIED settled in last racing to the backstretch, then raced wide into the stretch while proving no threat. TRAGIC MAGIC, reluctant to load, raced wide throughout while never menacing the leaders. RAJABLOU, reserved near the inside early, swung out five deep after a half and lacked a further rally. ZIPPIDY DO HAH was steadied out of tight quarters

acing as part of the second flight entering the first turn but soon retreated from contention.
