Footnotes

LAKOTA WOLF broke sharply to gain a clear advantage, relinquished the lead to stalk the pace three deep through the backstretch, continued in that path into upper stretch and responded to strong handling to strike the front in time. DE GREEN LIGHT was urged to dispute the pace along the inside soon after the break, dueled for command inside a rival on the turn, edged clear leaving midstretch but just failed to contain the winner. CHAMPAGNE TONY joined the pace between foes soon after the start, pressed the issue outside a rival to midstretch and gave way. HE'S SMASHED tracked just off the first flight four deep in the opening stages, then continued in that path into upper stretch while finishing evenly in late stages. SNOWKIN' GUN settled off the second flight four wide between foes in the opening stages, shifted out five wide racing through the stretch but continued with an effort to improve position. PISTOL PERSUASION tracked off the second flight near the inside, saved ground to upper stretch but lacked the needed closing response. LAZYLOVIN urged to gain a position inside a rival tracking the pace in second flight racing into the turn, gave way in upper stretch. CYBER BULLY broke slowly, was urged to contend five wide racing through the backstretch, shifted in entering the turn and steadily faded after a half. FRISKAWAY dropped out of contention early. CLOAK ROOM was never a factor. VALID DEVIL was urged to gain position between foes just off the second flight in the opening quarter but retreated from contention early.
