J JETT, in touch with the a rival on the pace in the opening stages while shifting to the rail, was eased off that foe to track the pace to the far turn, shifted out three deep in upper stretch while being urged to challenge, wrested command then lugged inwards in the closing stages despite some attempts to correct her course but proved best. ZENCAT tracked the first flight from just out of striking position near the inside for a half, shifted out four wide racing through the stretch but continued with interest to close the gap while prevailing for place honors. COUNTIN' ON U DOC went up to force the pace outside a rival from the outset, gained a clear advantage midway through the backstretch while shifting to the rail, set the pace into the far turn, couldn't contain J JETT, then steadied off that foe in the final stages when racing in close quarters late. LADY SCATTERLEY was forced wide racing into the first turn avoiding TRUE NIGHTMARE, was settled into stride to the far turn, moved to split foes three wide racing into upper stretch and continued with a steady late effort while gaining some position. EL CHARMER, reserved along the inside in last racing to the backstretch, shifted out five wide in upper stretch and made some belated progress. MOLLYMIA tracked just off the first flight racing three deep to the backstretch, advanced on the pacesetter to lodge a brief bid entering the far turn but failed to sustain her momentum through the last quarter. GO GO GRACIE settled into stride along the inside early but never gained contention. DIVINE DORIS tracked the leaders from out of striking distance racing three wide to the backstretch and steadily faded nearing upper stretch. D FIFTY

worked her way to the inside early gaining a position just off the second flight but steadily retreated racing through the far turn. TRUE NIGHTMARE drifted out racing into the first turn impeding a rival and never mounted a serious challenge. FOLLOWING THE RACE THE RIDER OF COUNTIN' ON U DOC LODGED A CLAIM OF FOUL AGAINST THE RIDER OF J JETT AND THE STEWARDS CONDUCTED A CONCURRENT INQUIRY. AFTER REVIEWING THE STRETCH RUN THE STEWARDS DISQUALIFIED J JETT FOR INTERFERENCE, PLACING HER THIRD.
